PRESIDENT'S MESSAGE - March, 2016:

Greetings to all! In the category of upcoming events, we now have a nominations committee in place and thankfully now have at least one nominee for each Board position. The slate of nominees will be published in the April newsletter and at the April meeting. If you would like to be a candidate or would like to nominate someone, contact Carolyn Sherwood. If you want to know more about our elections and the duties of various positions, read the Constitution and By-Laws section (pages 22 - 33) of your directory. The election will take place at the Annual Meeting on May 19.

The reception for our spring show, "Visions" is Thursday, March 3 at 6:00 - 8:00 pm. I hope you can all come and see how lovely the art looks on display! This reception should draw a lot of visitors beyond just our families and friends.

There have been questions about the jurying process for our shows. It varies slightly at the discretion of the show chair and, sometimes, by the requirements of the venue. For our current show, "Visions", we thought the gallery walls could accommodate about 60 to 70 pieces, depending on the size of the works that were submitted. Beyond that, the selection of works for the show and awarding of prizes was totally at the discretion of the juror.

A total of 110 pieces were entered; approximately 75 were accepted. Some of the entrants had both entries "not accepted". That happens to all of us but it always smarts. Please remember that jurying is subjective, according to the juror's preferences and how he or she feels individual pieces fit into the overall look of the show. A particular work that was not accepted here may win an award or even Best of Show elsewhere. It happens.

Minutes of General Meeting, February 18, 2016 - Dearborn Community Arts Center

President Kathy O'Connell called the meeting to order at 11:40 am. Fifty-seven members and guests were in attendance at the Dearborn Community Art Center. Due to time constraints the minutes which were published in the December 2015 newsletter were not read.

Treasurer Marilyn Bomarito reported the balance as of October 31 and the most recent ending balance of January 31, 2016. The motion to receive and file was made by Carolyn Sherwood.

Corresponding Secretary Joyce Manke asked the membership to please read the newsletter for updates.

First VP Programs Deb Maiale reported that future meeting venues would be in the newsletter.

Second VP Exhibitions Jackie Rybinski reported on the show schedule for 2016 and the initial proposal for a DSWPS exhibit at the Kelly Homestead/MOCAD. The highlights were as follows:

Padzieski Gallery, Dearborn MI, March 2-31

Anton Art Center, Mt Clemens MI, "Soliloquy," May 31 - June 30

Detroit Yacht Club Show, TBD

CCS Gallery, Detroit MI, cancelled for 2016

Crooked Tree Art Center, Petoskey MI, September 17 - November 19. The work juried into "Soliloquy" will go to Crooked Tree Gallery. Accepted artists may opt out of the show in Petoskey, but must notify Jackie Rybinski of that decision. The Anton Art Center pick-up date is June 30, 2016.

The Starkweather Gallery Show is scheduled for May and June of 2017.

Jackie Rybinski and Tracy Irwin will coordinate the Kelly Homestead/MOCAD exhibit. The success of the show will depend on the participation of a large group of members. Members are asked to email Jackie Rybinski their willingness to volunteer. Finally, discussion is ongoing for a show at the J. Charach Gallery at the Jewish Community Center in West Bloomfield, MI.

Third VP Directory Arlene Oakland reported that there was as yet no directory. She suggested that the membership use the fan-out sheet that the corresponding secretary updates at regular intervals.

Historian Julie Sabit distributed resumé forms to those members who have as yet not sent in a short bio and hard copy photo for the resume book.

STANDING COMMITTEES:

Membership Chair Jan Ducsay welcomed new members. The actual membership was given as an approximation close to 150.

Publicity Chair Shirley Hathaway informed membership that she needed information at least two months in advance for magazines like HOUR.

Scholarship Chair Marilyn Bomarito has begun conversations with College for Creative Studies regarding our annual scholarship. Jackie Rybinski, Jan Ducsay, Katy McNamee, Alice Smallwood, Carolyn Sherwood, and Kathy O'Connell will serve as committee members. The scholarship recipient will receive \$2,000.00 and a one year DSWPS membership.

The nominees are pre-selected by the college, and DSWPS makes the final determination. The scholarship winner presents her work at the May meeting. Since the founding of DSWPS in 1903 there has always been an annual scholarship.

Website Chair Katy McNamee appealed to the membership to send her information for the website. The newsletter is on the website.

Global Art Exchange Co-chairs Carol LaChiusa and Beverly Zimmerman reported an involvement of fifteen members.
