## About ArtPrize - 9/20 - 10/8/17 -- Grand Rapids

ArtPrize is an open, independently organized inter-national art competition which takes place for **19 days each fall in Grand Rapids, Michigan.** More than five hundred thousand dollars in prizes are awarded each year, which include a \$200,000 prize awarded entirely by public vote and another \$200,000 prize awarded by a jury of art experts.

Any artist working in any medium from anywhere in the world can participate. Art is exhibited throughout downtown Grand Rapids—museums, bars, public parks, restaurants, theaters, hotels, bridges, laundromats, auto body shops, vacant storefronts and office spaces. Artists and venues register for the competition then find each other through an online connections process in late spring. No one at ArtPrize selects a single artist or artwork, directs an artist where to show work or directs a venue what to show. In 2016, 1,453 works created by artists from 40 states and 44 countries were exhibited in 170 venues.

ArtPrize is free and open to the public and now attracts over 500,000 visitors, making it the most attended public art event in the world in 2014 and 2015, according the *The Art Newspaper*'s annual "Big Ticket List." *ArtPrize is a* 501(c)(3) *non-profit organization.*


"Detroit: Crossroad of Innovation," Hubert Massey's large-scale cartoon drawing for the fresco mural, is a 30-by-30-foot legacy piece that will serve as an attraction for more than 1.5 million annual metropolitan Detroit and foreign visitors. This public art work will reflect the region's people and values by carefully incorporating symbols and prominent images reflecting Detroit's pride and enduring influences from past, present and toward the future. Massey has engaged a team of young art assistants and students to be trained in the fresco technique popularized by the legendary artist Rivera, as demonstrated in his DIA rendering. The DRCFA legacy mural is greatly significant to the city of Detroit and the history of the facility where it's housed.

# A well attended meeting at DYC

Members brought in 1 - 3 pieces of art to be juried for the DSWPS

Thank you for bringing in your art work to provide 105 pieces from which to select a strong show. 54 pieces were selected with 8 awards. It was a lot of work for helpers moving paintings and the juror had a difficult job and spent a lot of time on the process. She thought our work was strong. She will write a letter explaining her thoughts in making her selections. Kim Fay mentioned she looks for work that she responds to in her gut and only two paintings affected her in that way. She had a strong reaction to them.

Some of our members entered one painting and it got in the show. Some entered three paintings and none got in. Some entered three paintings and all three got it. I am sorry if your work was not juried in. I know it is very disappointing. I just got juried out of four big shows myself: Midland, Muskegon, National Collage Society and the International Society of Experimental Artists. I know it costs money to enter and money to frame and sometimes there just isn't enough room for all the art turned in.

I want to address one situation. Some artists were concerned that their paintings were in the darker room as compared to others being in the lighter room. Kim began jurying in the lighter room and as paintings and works were juried out, they were taken to the darker room and work from the dark room was carried into the lighter room so that all the work was seen in the light. And boy, was there light and heat to go with it while the process was going on! The helpers said nothing to the juror and were just present to carry paintings out and in from one room to the other.

Many pieces selected were large. That is why the number stopped at 54. She did not want the show to be over crowded. I didn't get to address you as a group at the meeting regarding some refreshments. Starkweather will provide some cheese and crackers and some wine and water. I was hoping to get 12 people who would volunteer to bring in some additional treats for our reception. If you would like to bring something, please let me know. Again, thank you for your cooperation and to all who helped with this process. I heard the program was very interesting also. I hope you had a good day.

A question has been asked as to the time of the reception. It is on Saturday, Oct. 7 from 2 - 4 pm. Parking is free on streets and in parking lots.

**Directions to Starkweather:** From the west side if you get to M-59, Hall Rd., 20 mile road, (known by all 3 titles), and you travel east on M-59, pass Van Dyke (M-53) in Utica and go to the M-53 xway which is a mile or so east of Van Dyke, take the xway left which is going north to 32 mile road, make a left onto 32 mile, a Michigan left, and go a mile or so to Main Street which is Van Dyke Ave but known as Main Street in the town of Romeo. Turn right onto Van Dyke from 32 mile road and the Art Center is on the left corner which looks like the start of the 2nd block. Starkweather Alley separates the buildings on the left. It is not a road but a space and walkway.

The Art Center is a little north of 32 mile road on the NW corner of the intersection of 32 and Main Street, one block down. You can also go on Van Dyke Ave. (M-53) in Utica and take it all the way to 32 mile if you don't want the xway. It will just take a little longer.

Coming from the west side you can also take 696 to Van Dyke and going north on Van Dyke at 18 mile you can go to the right on the M-53 xway or to the left to continue on Van Dyke Ave. (M-53) to 32 mile. Many of you have GPS input. Hope you won't have any problems finding the gallery. Thank you all again.

That was the case in my work, ironically, after asking for rigor! (Be careful what you ask for!).

I am certain it will be a strong show and that the juror's decision-making process will be clear upon viewing it. We must all have a little bit of personal armor and battle-hardening when entering juried shows. Each juror has their own, highly personal selection process - it does not reflect on the quality of members' work but reflects every bit as much the personality, taste, and background of the juror. No one should feel discouraged if they did not get a piece into this show.

Again, thank you for your hard work. You allowed the rest of us to enjoy a lunch together as well as the follow-up program while the process took places seamlessly out of sight. I hope you were able to get some lunch at least! I am new to this Exhibition Liaison position and will be hopefully be a little more adept during the intake and opening to this show and well as the next.
