






## MEMBER ACCOMPLISHMENTS:

### The ANNEX GALLERY at 333 Midland

333 Midland is the name of the industrial site of what used to be the Lewis Stamping Plant, at 333 Midland St., Highland Park 48203. The Stamping Plant is now used as Artist Studio Space. It is a brick industrial building with a chainlink fencing surrounding the buildings and the small parking lot. The ANNEX GALLERY at 333 Midland is a separate building on the 333 Midland site. Midland St. crosses Hamilton Ave. south of W. McNichols and north of the Davison Fwy. 333 Midland is just west of Hamilton Ave. about halfway between W. McNichols and the Davison. You can park on Midland St. (no meters)

From I-96: take the Davison (MI 8) east past the Lodge (MI 10) to Hamilton Ave. in Highland Park. Turn left (north) on Hamilton Ave. Midland St. crosses Hamilton Ave. 333 Midland is just west of Hamilton Ave. (Ives Park is on the east side of Hamilton Ave., north of the Davison, and south of Midland St.)

From the Lodge (MI 10): Get off onto the Davison (MI 8) and proceed east to Hamilton Ave. in Highland Park. Midland St. is north of the Davison (MI 8) and crosses Hamilton Ave. (Ives Park on the east side of Hamilton Ave.) 333 Midland is just east of Hamilton Ave.

From I-75: get off onto the Davison (MI 8) west to Hamilton Ave. (which is past Woodward Ave.) At Hamilton turn right (north). Midland is less than a mile north of the Davison and crosses Hamilton Ave. (you will see Ives Park on the east side of Hamilton) Midland is a small road into an industrial area. 333 Midland is just on the east side of Hamilton Ave on Midland St.

From Woodward Ave. go west onto W. McNichols. At Hamilton Ave. go south to Midland Ave. (about half way between W. McNichols and the Davison Fwy. (Ives Park is on the east side of Hamilton just south of Midland St.) 333 Midland is just west of Hamilton Ave.

# "THE MIDLAND SHOW"

- All DSWPS members, whose dues are current, are eligible to enter. Art previously exhibited in DSWPS exhibits may not be entered
  - **\$25 entry fee** for up to two entries. A diptych or triptych will count as two entries if the panels are framed separately.
- All entries must be original works or examples of a multiple original edition created by the artist.

## **PRESENTATION**

- 2-D works have no maximum size. This is one show where you can think big!
- 3-D works have no weight limits
- The Annex Gallery does have pedestals, but no lockable cases for small pieces we advise to bring your preferred case or pedestal if desired.
  - 2-D artwork must be framed and wired in a sturdy and professional manner; no saw tooth handers
- Gallery wrap canvas with painted edges is acceptable with no nails or staples visible.
- Works or framing deemed unsafe, unsuitable for hanging or unstable will be disqualified.
  - Picture labels must be securely affixed to back or underside of artwork. Use DSWPS labels from front page of this form.

# JURYING at Madonna University

- Entries will be reviewed for conformance to the presentation guidelines by the Exhibition Committee.
  - Entries will be juried from actual work.
- Jurying intake is 10:00 10:55am on Saturday, September 22, before the General Meeting
- Jurying will only be for selecting prize winners, including the Nancy Prophit Award

## ABOUT OUR JUROR....

Robert Onnes is an established New Zealand sculptor working predominantly with steel and copper, exhibiting in many group and solo shows in New Zealand. He has become best known for his monumental steel work. In March 2015, Onnes relocated to Detroit where he is 333 Midland in Highland Park.

Onnes's background in electronics and as a developer has influenced the current processes he uses which include CAD design, CNC cutting and MIG welding.

One of the unique distinctions about his work is his interest in the constraints and possibilities found with using sheet metal to design three dimensional forms. Whilst they have the presence of a solid cast work they use quite a different process which Onnes has worked on perfecting over many years. The use of steel and copper allows the construction of substantial forms, yet they maintain an earthy organic quality which suit the themes of his works.

Much of his inspiration comes from modern industrial design and contemporary art critics including Dennis Duffon.
