In 1903, Lillian Burk Messer and 15 Charter Members created the Detroit Society of Women Painters and Sculptors. During the past 116 years, DSWPS has been a premier women's art organizations in the United States. Our organization has welcomed new and inspired established members who are interested in the promotion of art and wish to participate in the Society's activities. We have a proud history, but we must come to terms of our present organizational situation.

Unfortunately in 2019, DSWPS now finds itself at a pivotal point. We have a number of vacant board and committee positions. The majority of board and committee chairs who have decided to "retire," or "step down" have had their positions for over ten years. They have all done an excellent job, but they would like to enjoy DSWPS as members. We must identify, recruit and develop new leadership for our organization, if we are to do more than survive and "bask in the glory of past accomplishments."

Detroit Society of Women Painters & Sculptors Minutes of the General Membership Meeting – March 16, 2019 Detroit Historical Museum

Meeting called to order by Joan Smykowski, President, at 10:17 am.

New members Beth Brown, Dearborn, and Angie Larson, Plymouth, were introduced.

Minutes of the February 16, 2019 General Membership Meeting held at the Detroit Historical Museum were read. Deborah Maiale moved that the minutes be accepted, seconded by Arlene Oakland. Motion carried.

Reports:

President Joan Smykowski reported that the Executive Board has been very busy updating the DSWPS by-laws and policies. A slate of new officers will be presented at the annual meeting in May:

Real concerns have been presented by open positions that need to be filled as soon as possible, in particular, Treasurer. If these positions are not filled, DSWPS has three options: suspend the group temporarily; pay people to fill what are usually volunteer positions, close DSWPS completely. Does this group still need to exist?

Jean Thomas indicated that she has been Hospitality chair for 15 years. She will continue to handle memorials, but someone is needed to provide name tags and refreshments as appropriate for general and board meetings, as well as exhibition receptions depending on the venue. Carol LaChiusa is handling Nominations, contact her if interested.

Jackie Rybinski and Kathleen O'Connell spoke to the issue of Standing Committee Chairs tending to do everything rather than create committees or asking for help. There really needs to be a return to a structure with chair and committee members. Discussion was also had as to attendance at general membership meetings and whether requiring attendance for exhibition eligibility should be explored.

Corresponding Secretary: Joyce Manke indicated that it might be time to train someone to do the newsletter.

Treasurer: No report

1st VP Programs Jackie Rybinski reported that the next general membership meeting will be held on April 27 at the Black Box Gallery. Jim Nawara, juror for the exhibition will speak. Bring a chair and a bag lunch. It is also the day to pick up work. For more program info, see the newsletter.

2nd VP Exhibitions Kathleen O'Connell apologized that Jim Nawara reviewed the 125 entered images and selected only 31 works before she had a chance to really talk to him. The gallery owner had wanted 50 - 60 pieces. Possibly the owner will want to select some of the work not in the official exhibition for his gift shop, if so, any work chosen by the owner to be displayed would still be eligible for entry in a later DSWPS exhibition. Accepted work must be delivered April 1, the reception is April 5.

Historian Julie Sabit reported that she is accepting resumes or photos of artists' work for the DSWPS Book that is displayed at exhibitions. Please send her information.

Standing Committees:

Membership Joya Rush-Keli reported that Roslyn Rhodes and she partner on this committee. They are doing icebreakers before the meetings so we can get to know each other better.

Nominations Carol LaChiusa reported that she found joy in meeting new people. No other standing committee reports were offered.

Motion to adjourn by Maria Brow, seconded by Carol LaChiusa, motion carried.

Meeting adjourned at 11:05 am.
