For over 117 years, DSWPS has been a cultural institution in Southeastern Michigan. Our amazing organization was started because women could not show their work in public exhibitions. As we think of our past accomplishments and plans for the future, let us not forget that this is the second pandemic that DSWPS has survived. We survived and flourished after the 1918 Flu Pandemic (we had only been in existence 15 years). We are planning to do the same after the Covid 19 "Stay Home, Stay Safe" order is lifted. Our decision to meet and exhibit again will be based on scientific and medical guidelines. Though we are not had a general membership meeting since February, the Exhibition and Program Committees are planning for future exhibitions and meetings.
