# Detroit Society of Women Painters & Sculptors Minutes of General Meeting - October 19, 2017 at Detroit Yacht Club

**President Jackie Rybinski** called the meeting to order at 11:35 am. Twenty-five guests signed the attendance sheet. The president expressed sincere sympathy on the passing of former DSWPS president Ellen Tallant.

Recording Secretary Carolyn Sherwood: Jan Ducsay made the motion to accept the minutes of the September meeting as published in the newsletter. The motion was supported by Kathleen McNamee. Motion carried.

**Treasurer Marilyn Bomarito** reported a balance as of September 30, 2017. Erica Chappuis made the motion to receive and file the report. The motion was supported by Deborah Benedic. Motion passed. The treasurer also informed the membership that DSWPS had lost money on the last two shows. It was suggested that scheduling take-in during working hours might be one of the problems. Membership may be surveyed regarding this via the newsletter.

First VP Programs Chris Unwin reported the following meeting dates and programs:

October 19 - portrait demonstration by Ron Maniscalco.

November 18 - meeting at Madonna College- Printing demonstration by Nobuko Yamasaki and Lori Zurvalec.

December 16 - Tea at Noon. Townsend Hotel, Birmingham, Michigan. There is valet parking.

February 17 - meeting at Madonna College-intake of art for the show at Madonna.

Second VP Exhibitions Erica Chappuis reported that the intake for the Madonna show will be at the February 17 meeting at Madonna College. Erica also reported that she is looking into a larger venue, 333 Midland and Annex Gallery in Highland Park.

After the Salvador Salort-Pons lecture at Starkweather Gallery, Erica Chappuis and Jackie Rybinski spoke with the director of the DIA about showing DSWPS work at the Art Institute. He was informed that our founding members were influential in the growth of the DIA. Erica Chappuis also has plans to contact Cranbrook because of this same shared history with DSWPS. The president asked for volunteers to coordinate the Madonna show. Birgit Huttemann-Holz will be the juror. Her background is encaustic and ceramics. She currently has a studio in the Pioneer Bldg. at I75 and Grand Boulevard.

Third VP Directory and Membership Chair Jan Ducsa thanked Kathleen McNamee for delivering the directory to members at the September meeting. As of October, 2017 the membership was 144. Jan welcomed the new members who were present.

Webmaster Kathleen McNamee reported that five members were added to the website for a total of 144 members.

The meeting was adjourned at 12:24 pm. Motion made by Janet Kondziela and supported by Theresa Lannen.

#### Minutes of General Meeting - Saturday, November 18, 2017 at Madonna University

**President Jackie Rybinski** called the meeting to order at 11:24am. - 30 people signed the attendance sheet. Jackie introduced to us Chris Seguin, the art director for Madonna University. She gave us a warm welcome.

#### PRESIDENTS REPORT:

Jackie introduced the guests attending the meeting. She then talked about the survey in the current newsletter. She only received a reply from 12% of the members. Joyce will publish it again in the next newsletter, so we can get a better feel of how people feel about our club. Jackie wants to know how the members feel about meeting on Saturdays.

Recording Secretary Carolyn Sherwood was absent so the minutes were read by Jackie Rybinski. Marilyn Bomarito made a motion to accept the minutes as read, and seconded by, Joyce Manke.

Treasurer Marilyn Bomarito reported a Starting Balance, Deposits,

Expenses, with a ending Balance The treasurer's report was accepted as read by Janet Kondziela, and seconded by Joan Smykowski.

**PROGRAMS Chair Chris Unwin** announced the schedule of meeting places for the upcoming fiscal year. Arlene Oakland explained to members about the procedures for members to park at the Detroit Yacht Club without paying an entrance fee into the park. Chris then talked about the upcoming Holiday High Tea at the Townsend Hotel, on Saturday December 16<sup>th</sup>.

**EXHIBITION CHAIRMAN Erica Chappuis** talked about the DSWPS art show at the Madonna University in February. There is a 36" either way limitation on paintings. The intake and jurying will be on Saturday, February 17, 2018. There is no theme. The show will run from March 01, 2018 thru March 27, 2018. She is still working for us to have a show at the DIA, and also at Cranbrook.

Erica then explained a show we will have next fall at 333 Midland in Highland Park. She said it is edgier and more urban, and will be very conducive to large pieces of work. She recommends a two-week rental at \$350.00. We will have an opening and closing reception. We will have to supply our own hors d'ouerves and wine. Members reacted positively to this.

Jackie wants to open this show to outside women. Entry fee will be higher for outside exhibiters. Example: \$20/\$30. There will be a 30% commission fee for all sold items. It was suggested we book the last two weeks in September, or the last week in September and the first week in October.

**ANNOUNCEMENTS:** Lori Zurvalec announced the Grosse Pointe Congressional Church opened an Art Gallery on site. Joan Smykowski announced the Potters' Market at 26000 Evergreen in Southfield. It is December 01st to 3rd. Joyce Manke announced information about the Scarab Club's Gold Medal Show.

Motion to adjourn the meeting at 12:12 pm was made by Marilyn Bomarito, and seconded by, Janet Kondziela
